Because Vitality Nutritional Drinks are classified as a meal replacement or food product, our Canadian Office has been trying to get the General Sales Tax (GST) on Nutritional Drinks repealed. We have been working with the Canadian government on this issue for nearly five years and we are happy to report we have finally succeeded! As of January 15, 1996, Distributors no longer have to pay GST on this product.

Commission Payment Withholding Tax

Distributors who sponsor individuals living in countries outside the one they themselves reside in may be subject to a withholding tax. Many countries, (including the U.S.) have laws requiring that a withholding be made on the commissions paid outside of that country. For example, Jamaica requires a 25 percent withholding tax and the Philippines require 30 percent. Consult your tax advisor about how best to handle your situation.
